

| Keysight Software Manager (KSM) | The operations and administration system for software access that includes the self-service Enterprise Licensing Portal for provisioning and re-mixing of subscription software capacity pools. |
| Subscription Software | Offers access to software licenses through the term of the subscription. |
| Subscription License Types | Node-locked: Use this license on one specified instrument/ computer. |
| | • Transportable: Use this license on one instrument/computer at a time. It comes with the option to transfer it to another instrument/computer using Keysight Software Manager. |
| | • Floating: Networked instruments/computers may access a license from a server one at a time. Purchase multiple licenses for concurrent usage. |
| Subscription Software Support | Software subscription licenses include software support through the term of the license. |
| | Ensure your software is always current with the latest enhancements and measurement standards. |
| | Gain additional insight into your measurement challenges with live access to our technical experts. |
| | Stay on schedule with fast turnaround times and priority escalations when you need support. |
| Capacity Pool | A pool of software that is yours to define and deploy to address every phase of your product lifecycle. |
