
## **Overview**

#### **Supplier Compliance Management Program**

- Develop written objectives, targets, and implementation plans to improve Keysight's supplier compliance management program performance, including periodic review with management.
- Address development and control of Keysight program documents and records to meet regulatory, privacy, and company requirements.
- To maintain a strong partnership with our suppliers, including a shared commitment to leadership in sustainable practices, technology, and business operations to ensure our customers receive high-quality and responsibly manufactured products.
- Ensuring that suppliers conform to the Keysight's standards, procedures, Supplier Code of Conduct and adhere to local country regulations.
- Consist of four key steps, Define Requirements, Communication, Assessment/Audits and Knowledge Buildings, which helps drive alignment between the company and our supplier.

### **Approach**

Overall supplier compliance management process including define requirements, communication, assessment and knowledge building.

- The Supplier Code of Conduct <sup>1</sup> (the Code) establishes Keysight's expectations for its suppliers, including ethical business practices, social responsibility, environmental sustainability. and product quality.
- The Code principles are based on the Responsible Business Alliance (RBA) Code of Conduct. <sup>2</sup>
- Suppliers shall conduct business in accordance with this Code, applicable law and regulations wherever the suppliers may be located.
- Where differences arise between standards and legal requirements, the stricter standard shall apply, in compliance with applicable law.




# Assessment/ Audit
