SAS-4 Compliance Test Application - At A Glance

The Keysight D9040SASC SAS-4 Compliance Test Application enables the testing of SAS-4 devices with the Keysight Infiniium oscilloscope, based on the SAS-4 Standard that defines the physical layer of the SAS interconnect. Serial Attached SCSI (SAS) protocol relates to data storage interface for computer storage devices, such as hard disks and tapes, used in high-performance servers. SAS-4 operates at 22.5 Gb/s.

The SAS-4 Compliance Test Application:

- Lets you select individual or multiple tests to run.
- · Lets you identify the device being tested and its configuration.
- · Shows you how to make oscilloscope connections to the device under test.
- · Automatically checks for proper oscilloscope configuration.
- Automatically sets up the oscilloscope for each test.
- Provides detailed information for each test that has been run, and lets you specify the thresholds at which marginal or critical warnings appear.
- Creates a printable HTML report of the tests that have been run.

NOTE The current SAS-4 compliance test application is based on the Serial Attached SCSI-4 (SAS-4) Specification Revision 09.

NOTE	The group of tests specified in this Methods of Implementation document pertains to the SAS-4 specifications. The specification defines the electrical requirements of the signals for 1.5, 3.0, 6.0,

- Infinitum Z-Series, V-Series, Q-Series, or UXR-Series (UXR0334A) oscilloscope. Keysight recommends using 33 GHz and higher bandwidth oscilloscope.
- The minimum version of Infiniium oscilloscope software (see the D9040SASC SAS-4 Compliance Test Application release notes).
- D9040SASC SAS-4 Compliance Test Application software.
- Keyboard, qty = 1, (provided with the Keysight Infiniium oscilloscope).
- Mouse, qty = 1, (provided with the Keysight Infiniium oscilloscope).
- Keysight also recommends using a second monitor to view the automated test application.

If you purchased the D9040SASC SAS-4 Compliance Test Application separately, you must install the software and license key.



Installing the Software

- 1 Make sure you have the minimum version of Infiniium Oscilloscope software (see the D9040SASC test application release notes) by choosing **Help>About Infiniium**... from the main menu.
- 2 To obtain the SAS-4 Compliance Test Application, go to Keysight Web site: http://www.keysight.com/en/pc-1152185/oscilloscope-software.
- 3 Navigate to the SAS-4 Compliance Test Application software download.
- 4 Follow the instructions to download and install the application software.

Installing the License Key

To procure a license, you require the Host ID information that is displayed in the Keysight License Manager application installed on the same machine where you wish to install the license.

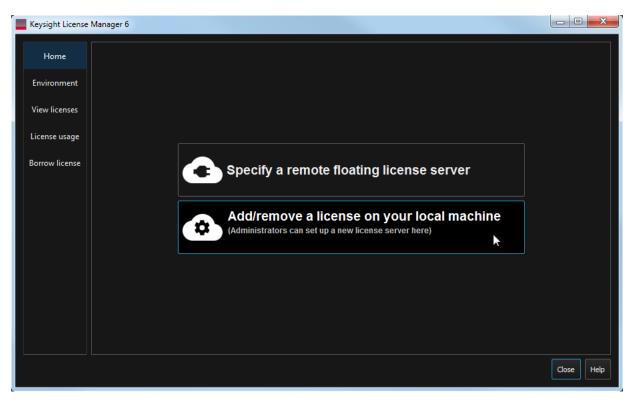


Figure 4 Home menu options to install licenses on Keysight License Manager 6

Before running the SAS-4 automated tests, you must calibrate the oscilloscope. After the oscilloscope has been calibrated, you are ready to start the SAS-4 Compliance Test Application and perform the measurements.



2 Preparing to Take Measurements

Calibrating the Oscilloscope

	 If you have not already calibrated the oscilloscope and probe, see Chapter 9, "Calibrating the Infiniium Oscilloscope.
NOTE	If the ambient temperature changes more than 5 degrees Celsius from the calibration temperature, internal calibration should be performed again. The delta between the calibration temperature and the present operating temperature is shown in the Utilities>Calibration menu.
NOTE	If you switch cables between channels or other oscilloscopes, it is necessary to perform cable and probe calibration again. Keysight recommends that, once calibration is performed, you label the cables with the channel on which they were calibrated.

Figure 5 shows the procedure to launch the SAS-4 Compliance Test Application and Figure 6 shows the SAS-4 Compliance Test Application default window. The tabs in the main pane show the steps you take in running the automated tests:

Tab	Description	
Set Up	Lets you identify and set up the test environment, including information about the device under test.	
Select Tests	Lets you select the tests you want to run. The tests are organized hierarchically so you can select all tests in a group. After tests are run, status indicators show which tests have passed, failed, or not been run, and there are indicators for the test groups.	
Configure	Lets you configure test parameters. This information appears in the HTML report.	
Connect	Shows you how to connect the oscilloscope to the device under test for the tests to be run.	

Tab	Description
Run Tests	Starts the automated tests. If the connections to the device under test need to be changed while multiple tests are running, the tests pause, show you how to change the connection, and wait for you to confirm that the connections have been changed before continuing.
Automation	Lets you construct scripts of commands that drive execution of the application.
Results Contains more detailed information about the tests that have been run. You can char thresholds at which marginal or critical warnings appear.	
HTML Report	Shows a compliance test report that can be printed.

NOTE

The configuration options shown under the **Set Up** tab of the SAS-4 Compliance Test Application main window dictate the availability of various tests. You may have to select more than one configuration option to make some tests available, else they appear unavailable/disabled. 

Making Hardware Connections for SAS-4 Compliance Testing

The required hardware and interconnections vary, depending on the configured test pattern source and use of RealEdge feature in Infiniium Q-Series and Z-series oscilloscopes.

Infiniium Q-Series and Z-Series oscilloscopes support RealEdge technology that allows for 63 GHz of bandwidth on two channels. In these oscilloscopes, there are two additional 1.85 mm channel inputs, 1R and 3R that enable support for RealEdge feature. Hence, if you are using RealEdge, the connection diagrams will vary from the setups not using RealEdge.



The Test Pattern Source setting offers the following options:

- BIST_L
- BIST_T
- SavedWFM

BIST_T

For BIST_T as the test pattern source, there is no additional device or more specifically a pattern generator required. The SAS test application does not control the stimulus using a pattern generator. The user must manually configure the test patterns during tests. The SAS test application prompts the user for test patterns.

Since there is no pattern generator involved in this arrangement, the connection setup involves the SAS Test Fixture attached to SAS DUT and connected with Channel 1 and Channel 3, Channel 2 and Channel 4, or Channel 1R and 3R (for RealEdge) of the oscilloscope.




Figure 7 BIST_T Connection Diagram with Channel 1 and Channel 3





Figure 8 BIST_T Connection Diagram with Channel 2 and Channel 4





BIST_L

With the BIST_L test pattern source, the SAS test application controls the stimulus using 81134A, N4903B, M8020A, or M8040A to generate the required test pattern and the DUT then reads/loops back the test pattern generated by the stimulus.

For the 22.5 Gbps bit rate, M8020A and N4903B require a multiplexer to expand the bit rate up to the required limit. M8020A uses M8061A or M8062A as the multiplexer while N4903B can use either N4876A or M8061A as the multiplexer. Refer to the following connection diagrams.

Additionally, the connection diagrams display the required connections when using M8040A BERT for OOB and non-OOB tests.




Figure 10 BIST_L Connection Diagram with 81134A with Channel 1 and Channel 3




Figure 11 BIST_L Connection Diagram with 81134A with Channel 2 and Channel 4




Figure 12 BIST_L Connection Diagram with 81134A with Channel 1R and Channel 3R




Figure 13 BIST_L Connection Diagram with N4903B JBERT and M8061A Multiplexer with Channel 1 and Channel 3





Figure 14 BIST_L Connection Diagram with N4903B JBERT and M8061A Multiplexer with Channel 2 and Channel 4








Figure 16 BIST_L Connection Diagram with N4903B JBERT and N4876A Multiplexer with Channel 1 and Channel 3




Figure 17 BIST_L Connection Diagram with N4903B JBERT and N4876A Multiplexer with Channel 2 and Channel 4




Figure 18 BIST_L Connection Diagram with N4903B JBERT and N4876A Multiplexer with Channel 1R and Channel 3R




Figure 19 BIST_L Connection Diagram with M8020A JBERT with Channel 1 and Channel 3




Figure 20 BIST_L Connection Diagram with M8020A JBERT with Channel 2 and Channel 4




Figure 21 BIST_L Connection Diagram with M8020A JBERT with Channel 1R and Channel 3R





Figure 22 BIST_L Connection Diagram with M8040A JBERT with Channel 1 and Channel 3





Figure 24 BIST_L Connection Diagram with M8040A JBERT with Channel 2 and Channel 4





BIST_L Connection Diagram with M8040A JBERT with Channel 2 and Channel 4 for OOB Tests




Figure 26 BIST_L Connection Diagram with M8040A JBERT with Channel 1R and Channel 3R



SavedWFM

When you select SavedWFM, the SAS test application analyzes the loaded waveform. There is no specific requirement for connection. You may leave the current connection as it is. The application runs on the previously saved WFM file only and does not require a live signal.




Figure 30 Selecting SAS Center Spreading Spread Spectrum Tests



This section describes the calibration procedures for Keysight Infiniium Oscilloscopes other than the UXR-series oscilloscopes. For the calibration information related to the UXR-series oscilloscopes, refer to *Keysight Infiniium UXR Real-Time Oscilloscopes User's Guide*.

Additionally, probe calibration and de-skew steps have been described in this section. To get more information, you can refer to the respective probes documentation.



Required Equipment for Oscilloscope Calibration

To calibrate the Infiniium oscilloscope in preparation for running the SAS-4 automated tests, you need the following equipment:

- Keyboard, qty = 1, (provided with the Keysight Infiniium oscilloscope).
- Mouse, qty = 1, (provided with the Keysight Infiniium oscilloscope).
- 9000, S-Series and 90000A series oscilloscope: Precision 3.5 mm BNC to SMA male adapter, Keysight p/n 54855-67604, qty = 2 (provided with the Keysight Infiniium oscilloscope).
- V, X and Z series oscilloscope: 3.5mm Female to Female adapter, Keysight p/n 5061-5311, qty = 2 (provided with Keysight Infiniium oscilloscope).
- Calibration cable (provided with the Keysight Infiniium oscilloscopes). Use a good quality 50 Ω BNC cable.

To Run the Self Calibration

NOTE

Let the Oscilloscope warm up before adjusting. Warm up the Oscilloscope for 30 minutes before starting calibration procedure. Failure to allow warm up may result in inaccurate calibration.

The self calibration uses signals generated in the Oscilloscope to calibrate Channel sensitivity, offsets, and trigger parameters. You should run the self calibration

- · yearly or according to your periodic needs,
- when you replace the acquisition assembly or acquisition hybrids,
- when you replace the hard drive or any other assembly,
- when the oscilloscope's operating temperature (after the 30 minute warm-up period) is more than ±5 °C different from that of the last calibration.

Internal or Self Calibration

NOTE

Calibration time: It takes approximately 1 hour to run the self calibration on the Oscilloscope, including the time required to change cables from Channel to Channel.

This will perform an internal diagnostic and calibration cycle for the oscilloscope. For the Keysight oscilloscope, this is referred to as Calibration. This Calibration will take about 20 minutes. Perform the following steps:

- 1 Set up the oscilloscope with the following steps:
 - a Connect the keyboard, mouse, and power cord to the rear of the oscilloscope.
 - b Plug in the power cord.
 - c Turn on the oscilloscope by pressing the power button located on the lower left of the front panel.
 - *d* Allow the oscilloscope to warm up at least 30 minutes prior to starting the calibration procedure in step 3 below.
- 2 Locate and prepare the accessories that will be required for the internal calibration:
 - a Locate the BNC shorting cap.
 - *b* Locate the calibration cable.
 - c Locate the two Keysight precision SMA/BNC or SMA female to female connector adapters.
 - d Attach one SMA adapter to the other end of the calibration cable hand tighten snugly.
 - e Attach another SMA adapter to the other end of the calibration cable hand tighten snugly.

- b Click **Start** to begin calibration.
- c Follow the on-screen instructions.

d During the calibration of any Oscilloscope Channel, if the oscilloscope prompts you to perform a Time Scale Calibration, select **Standard Cal and Default Time Scale** in the **Calibration Options** dialog.




Figure 36 Selecting options from the **Calibration Options** dialog

The options under the **Calibration Options** dialog are:

- **Standard Calibration**—Oscilloscope does not perform time scale calibration and uses calibration factors from the previous time scale calibration and the reference signal is not required. The rest of the calibration procedure continues.
- **Standard and Time Scale Cal**—Oscilloscope performs time scale calibration. You must connect a reference signal to the Oscilloscope Channel, after ensuring that the reference signal meets the following specifications. Failure to meet these specifications result in an inaccurate calibration.
- Standard Cal and Default Time Scale—Oscilloscope uses the default time scale calibration factors and does not require the 10 MHz reference signal. The rest of the calibration procedure continues.
- e Disconnect everything from all inputs and Aux Out.
- f Connect the calibration cable from Aux Out to a specific Channel.
- g Connect the calibration cable from Aux Out to each of the Channel inputs as requested.
- $h\,$ Connect the 50 Ω BNC or SMA cable from the Aux Out to the Aux Trig on the front panel of the Oscilloscope.
- *i* A Passed/Failed indication is displayed for each calibration section. If any section fails, check the calibration cables and run the Oscilloscope **Self Test...** in the **Utilities...** menu.
- *j* After the calibration procedure is completed, click **Close**.

NOTE

These steps do not need to be performed every time a test is run. However, if the ambient temperature changes more than 5 degrees Celsius from the calibration temperature, this calibration should be performed again. The delta between the calibration temperature and the present operating temperature is shown in the **Utilities>Calibration** menu.

Channel-to-Channel De-skew

NOTE

For Infiniium 90000 X-Series, S-Series, V-Series and Z-Series oscilloscopes, you must manually enable the Aux Output:

From the oscilloscope's main menu, choose Utilities>Calibration Output....
 In the Calibration Output dialog, select the Aux Out Enable check box.

This procedure ensures that the timing skew errors between Channel 1 and Channel 3 are minimized. In addition to the required equipment, you need:

- SMA T-adapter
- Additional BNC to SMA male adapter (two precision 3.5 mm BNC to SMA male adapters are provided with the oscilloscope)

To perform the Channel-to-Channel de-skew:

- 1 Connect the Channel 1 and Channel 3 SMA cables to the oscilloscope's Aux Out:
 - a Leave the RG-316 cables and SMA adapters on Channel 1 and Channel 3.
 - b Install a BNC to SMA male adapter on the oscilloscope Aux Out.
 - c Connect the middle branch of the SMA T-adapter to the SMA adapter on the Aux Out BNC.
 - *d* Connect the far end of the cable from the Channel 1 SMA adapter, to one branch of the SMA T-adapter on the Aux Out.
 - e Connect the far end of the cable from the Channel 3 SMA adapter, to the other branch of the SMA T-adapter on the Aux Out.




Figure 37 Oscilloscope connections

If the setup file is not available, it can be created by following the instructions in "INF_SMA_Deskew.set Setup File Details".

3 Observe the Channel-to-Channel skew.

The oscilloscope display should look similar to the picture below. A falling edge of the square wave is shown in a 200 ps/div horizontal scale. The upper portion of the screen shows Channel 1 (yellow trace) and Channel 3 (purple trace) superimposed on one another. The lower portion of the screen is the differential signal (green trace) of Channel 1 minus Channel 3. The top two traces provide for visual inspection of relative time skew between the two Channels. The bottom trace provides for visual presentation of unwanted differential mode signal resulting from relative Channel skew (and to a much lesser extent from other inevitable Channel mismatch parameters

like gain and non-linearity). The picture below is an example of exaggerated skew between Channel 1 and Channel 3, measured to be about 50 ps with the cursor.

The following picture shows the desired effect of no skew between the cables. Note that the Channel 1 (yellow trace), Channel 3 (purple trace) traces overlap, and the differential signal (green trace) is flat. If this is not the case, then perform the following steps to reduce the skew between Channels 1 and 3.




Figure 40 No Channel-to-Channel Deskew

- 4 De-skew the Channels:
 - a Choose Setup>Channel 3....
 - b Move the Channel Setup dialog to the left so you can see the traces.
 - c Adjust the **Skew** (by clicking on the < or > arrows) to achieve the flattest response on the differential signal (blue trace).

- d Click **Close** to close the Channel Setup dialog.
- 5 Disconnect the cables from the T-adapter on the Aux Out BNC. Leave the cables connected to the Channel 1 and Channel 3 inputs.

NOTE

Each cable is now calibrated for the oscilloscope Channel it is connected to. Do not switch cables between Channels or other oscilloscopes, or it will be necessary to calibrate them again. It is recommended that the cables be labeled with the Channel they were calibrated for.

INF_SMA_Deskew.set Setup File Details

NOTE

For Infiniium 90000 X-Series, S-Series, V-Series and Z-Series oscilloscopes, you must manually enable the Aux Output:

- 1. From the oscilloscope's main menu, choose Utilities>Calibration Output....
- 2. In the Calibration Output dialog, select the Aux Out Enable check box.


